In addition below you will find the process for students transferring their financial aid awards. Rene Blanco is our point person for Financial Aid, 858-635-4544, rblanco@alliant.edu, if you need additional information. The application fee 9\$50) has been waived for Sweetwater students.

The steps that a student needs to follow to have their FAFSA form be sent to Alliant:

- Go to the FAFSA web page to proceed with a correction to the FAFSA form
- Add Alliant as a school to receive the form (Alliant code-011117)
- If a student has been awarded Cal Grant, Pell Grant or the like they will need to complete the G10 Form that they should have received with their California Student Aid Report* which states they (the students) want their aid redirected to Alliant.

*As a side note, remember the award is based on tuition and expenses from a specific school and may change slightly based on the tuition and expenses from another school. This does not change their ability to receive aid but may slightly change the amount.
