Today's truth is that there are about six teachers remaining who need placements for next year. This subset represents teachers who were declared in excess at the end of the 12-13 academic year. The original excess pool was comprised of about fifty teachers. The excess teachers were not laid off. Thus they are entitled to positions and must be paid. As Human Resources has received PARs we have placed the teachers accordingly. Teachers report on July 22, 2013 and we have not been receiving an abundance of PARs for which these teachers qualify. Hence, I am writing to you to attempt to identify a solution for these six.

In some contexts, there are partial assignments available. The District, of course, cannot force a teacher to reduce his/her FTE. The teacher would need to do that of his/her own volition. For example, there is a 0.6 fte girls PE position available at Castle Park Middle. There is a female PE teacher in the excess pool in need of a placement. Human Resources can assign her to this position. However, Finance would need to make the position a full-time position (provide 0.4 fte) unless she agreed to voluntarily reduced to a 0.6 fte assignment this year. The site, of course, could assign her to other teaching duties within the scope of her credential during the remaining periods. She would only receive the same amount of preparation time as her other full-time peers. This may also alleviate the need for HR to move a CSA to another location so that CPM can get a female CSA to provide locker-room coverage during the periods that a female PE teacher is not on site. It is my understanding, from the principal, that the other two PE teachers are both male. This is obviously just one example. We need to, at some point, make a decision about their placements and how long we "hold-out" for a full-time PAR in their respective credential areas. Ultimately, some may be assigned to sites until positions become available within the scope of their credentials.
